Sculptra® Aesthetic is a unique and long-lasting filler. The injectable material is poly-L-lactic acid. As an injectable, non-surgical procedure, it restores the youthful, robust fullness to the face that is lost with the aging process. Sculptra® Aesthetic should be thought of as a facial “volumizer” (restores fullness) rather than just a superficial wrinkle filler.

How does Sculptra® Aesthetic work?

Sculptra® Aesthetic stimulates the growth of new collagen which increases skin thickness creating a fuller, more youthful appearance to the mid and lower portions of the face. Two or more treatment sessions spaced four to six weeks apart may be required for optimal results. Visible improvement may last two years or longer.

Does Sculptra® Aesthetic replace facelift surgery?
